

HALFWAY TOYOTA & HALFWAY LEXUS BIG WIN COMPETITION TERMS & CONDITIONS

1. Promoter

2. Competition Period

3. Eligibility

The competition is open to all customers who purchase a new or pre-owned vehicle from any participating Halfway Toyota or Halfway Lexus dealership during the competition period.

Customers who finance their purchase through Toyota Financial Services ("TFS") will receive one additional entry.

The After-Sales competition is open to customers who book a vehicle service or spend R1,000 or more on genuine Toyota parts during the campaign period.

The competition is not open to:

Employees, directors, members, agents, or consultants of the Promoter, its affiliates, or suppliers.

Immediate family members of the above persons.

Any other person professionally connected with the competition.

4. How to Enter

Each eligible purchase will automatically generate one entry.

An additional entry will be granted for qualifying TFS financing.

After-Sales entries are automatically captured upon meeting the qualifying spend.

5. Prizes
